

Useful information about the services offered by Bis-Net



Welcome to Bis-Net

This booklet has been created to tell you more about the Behaviour Intervention Support Network, known as Bis-Net .

Bis-Net is a service delivered by Exeter based charity, CEDA. CEDA, has been providing a range of opportunities for disabled adults, children and young people from all across Devon since 1988.



BIS-net was founded in 2013, thanks to a 5 year grant from the National Lottery Reaching Communities Fund. It was created to provide more support for children and young people with Neurological differences and their families.

The service was shaped by a steering group made up of parents and young people, as well as information collected from several consultation events, to ensure the service was as user led as possible.

What is **Bis-Net**?

OUR PURPOSE

- To support families and professionals caring for children and young people with Neurological differences such as Autism and ADHD/ADD.
- To support individuals with Neurological differences.
- To keep ourselves informed in the latest understanding of Neurodiversity, developments in Neuro Science and sharing it's importance and value to the community.

Bis-Net services

Behaviour Support Consultation

Who for?

Families supporting any young person with distressed or unsafe behaviour and Neurodiverse traits such as Autism and ADHD. Who attends is established on a case by case basis. Support is person centred and flexible around the needs of the family and can include long term 1 to 1 support with the child/young person. Families can self refer or may be directed through children's services.

Aspirations

To be bespoke! Wherever possible Bis-net hope to create conditions where parents and young people can feel safe, in control and able to set their own outcomes. Bis-net recognise that the pathway to regulation comes through improving an individuals self-awareness and in turn help them to create a roadmap of support. The support intends to make a significant difference to participants,

- Health & Wellbeing
- Being Safe
- Confidence & Self Esteem
- Education
- Communication & Interaction



There is no one size fits all. Bis-net are adopting modern regulation supports and approaches for neurodivergent learners and the families around them. These include some of the following:

Relational, Low Demand, Trauma Informed, Co-regulation, Declarative language, informing and building understanding around Interoception and Alexithymia and Cognitive processing differences.

We hope these approaches empower parents to recognise they are the experts in their children's lives and become great advocates for them. We hope young people can become great advocates for themselves.

Provision

Consultation is priced at £53 / hour. We recommend a minimum of 10 sessions, but will assess and advise families on an individual basis. There is no maximum limit.

Attendance can take place on a weekly or monthly basis.

Appointments take place over phone or video call. Whilst there are restrictions we do try to offer some outreach to meet face to face.

Attend meetings alongside families, including Child in Need, EHCP review.

Bis-Net services

Bis-net, Early Help family support

Who for?

For parents, carers, who are supporting children/young people with distressed or unsafe behaviour and have been referred through Devon Children and Families Partnership, Early Help.

Aspirations

• Improve Health and Wellbeing

To help parents, carers take a moment to press pause. Help them describe, validate and reflect on their experiences supporting distressed, unsafe behaviour. To help them move away from **'Crisis Mindset'**. This can be characterised as...

- Feeling frantic and/or desperate
- Operating in a day-to-day survival mode
- Feeling like you must try everything
- Only able to focus on the short-term

Additional Outcomes

The parents and family will be asked to focus on **one** of the following outcomes to work towards

- Being Safe: Parents will be guided on how to de-escalate and support 'meltdowns'.
- Increased Confidence & Self Esteem: Parents will learn how to create conditions that help them feel more connected with their child.
- **Education:** Parents will develop further understanding in their child's diagnosis or traits. Parents will be signposted towards modern emotional regulation supports for neurodivergent learners.
- **Communication & Interaction:** Parents will discover optimal communication supports for their child

<u>Provision</u>

The course is priced at £350. This allows families

- Up to 6 hours of contact time with your consultant
- Weekly appointments conducted over phone or video call
- One optional 'check in' meeting that can be booked flexibly
- By arrangement, attendance to x1 TAF meeting
- Summary report shared with Team Around the Family through Rights4Children platform





Bis-Net services

'Check in'



£20 per session (30 minutes)

Whilst not as bespoke as our other options we hope this allows parents, carers, young people an opportunity to get in touch. At a reduced rate and for a shorter <u>30 minute</u> meeting here are some of the enquires we expect to be able to help with.

- I need help supporting distressing / unsafe behaviour. Where do I start?
- I need someone to reflect and debrief with following an episode of distressing / unsafe behaviour.
- It's the holidays, help!
- I'd like to check back in with my Bis-net consultant. Update on progress and discuss what may still be challenging.
- I've been on waiting lists for all sorts of services. I could really do with some advice right now.
- There's little help. I feel I am not being listened to by professionals or our education setting






Decide which service you would like to access and how this is going to be funded. Please complete the referral form included in this pack and return to us. bisnet@cedaonline.org.uk

Our service is very personal and can get busy, depending on your needs you could be placed on our waiting list. Wait times vary and you may have to wait 3 - 6 months. Once you are at the top of the list, we will contact you with available slots that match those you tick on the referral form. If you can be flexible, the wait time may be reduced.

Services will be complete. You will receive a final report which will cover the work that has been completed and include recommendations for the future, including continued support if required.

Information for organisations referring a family to Bis-net

E.g. Early Help, School SENCO, Children's Integrated Services and GP's



and Families



- Confirm receipt of receiving a purchase order from you
- Estimate a waiting period for family to start services. This is from point of receiving a purchase order and referral information
- Contact families directly if we have received our referral form, RFAS or CYP100
- Access and upload information to Rights for Children platform if we have been invited to do so
- Attend TAF's, Child In Need and other meetings remotely using video call
- Signpost families to organisations that can help fund our consultation
- Recommend other partner organisations whose services may be accessed sooner than ourselves or have expertise in a more specific field

We can not:

- Offer services without confirmation of payment
- Track down family contact details from a purchase order. This requires referral form, RFAS or CYP100
- Offer services directly in family home
- Offer time to help families access funding other than in a signposting capacity
- Liaise with other professionals around the family unless this time can be funded




